The Board of Directors recommends you vote FOR the following Class II director nominees:

1. To elect two Class II directors to hold office until the 2023 Annual Meeting of Stockholders or until their successors are elected Class II directors

The Board of Directors recommends you vote FOR proposals 2 and 3.

2. To ratify the selection, by the Audit Committee of the Company's Board of Directors, of PricewaterhouseCoopers LLP as the independent registered public accounting firm of the Company for its fiscal year ending December 31, 2020;
3. To approve and adopt amendments to the Company's Amended and Restated Certificate of Incorporation (the "Reverse Stock Split Amendment") to (i) effect a reverse stock split of the Company's common stock on or before August 3, 2021 at a ratio ranging from 1-for-2 shares up to a ratio of 1-for-7 shares, which ratio will be selected by the Company's Board of Directors and set forth in a public announcement (the "Reverse Stock Split"), and (ii) reduce the number of authorized shares of the Company's common stock by a corresponding ratio (the "Authorized Share Reduction");
4. To transact such other business as may properly come before the Annual Meeting or any adjournment or postponement thereof.
